



### **POSeidon Control System** ®

- The Intelligent Cash Register Supervision System developed by Justice Security aims to help retail and wholesale companies to
  - reduce inventory shortages
  - and to investigate internal violations.





## What is POSeidon®?

POSeidon® Control System is a special cash register control system developed by Justice Security in 2006, the purpose of which is to reduce inventory shortages of unknown Origin in commercial units, and to identify the causes.

The system makes visible acts committed at cash registers wilfully or negligently that result in damage or loss.

Its installation also has a special preventive effect due to the fact that the archive of the system could be used as evidence in official proceedings.



## How does it work?

The POSEIDON® system consists of three components.

- **1.** Cameras monitoring the cash registers.
- 2. Data received from the cash registers, which are displayed on the camera's images, so that transactions at the cash registers can be precisely tracked (e.g. which product the cashier is scanning, which product does he give discount on, what is indicated on the final receipt, how much money is put into the cash box, etc.).

**3.** Investigative software. It is practically impossible to track the feed of all cameras all the time and notice all violations. This is why the JUSTICE Security team developed a software that can detect and retrace wilful or accidental violations.







This security technology solution connects the video data of the cameras to the text data of the cash registers.

The most important part of the system is, however, an investigative software, which is a Hungarian innovation.

This program is capable of filtering out suspicious transactions from amounts of images and data that could not be processed by live personnel.

The **soul** of the POSeidon system is the **POSeidon Investigation**® module.

This module helps to investigate manipulations at the cash register, for which it evaluates video and tape data, cancelled transactions, zero receipts, returns, goods, etc.



You can freely prepare custom reports and/or set standard reports, which are generated automatically.



#### Range of functions of **POSeidon Investigation** ®

The entire data stock is examined based on terms such as "cancelled transaction", "return goods", "cash drawer opened without cash register process", etc. After which the system creates a report.

In such cases, the report displays all processes when for example the cash drawer was opened without a cash register process.

In addition to cash register processes, in suspicious cases, POSeidon can present all video footage associated with the process concerned on the press of a single button.



In addition to the search criteria, temporal filters can be set and/or particular cash registers designated. By setting multiple search criteria combined with filters, various reports can be generated according to the needs of the customer.

#### **POSeidon Investigation** ® Analysis

We are able to monitor multiple types of businesses (e.g. grocery, grill food and tobacco shop beside it) simultaneously.



#### **Calendar section:**

The blue square indicates that there is footage available.

#### Timeline:

- Red: motion detector camera
- Green: cash register information
- The continuous green line shows the time of operation of the system.



A customised filter can be created for each business, which may contain custom and mixed means of payment, even vouchers.



Using the filters, all goods and cash traffic can be tracked.


#### An example:

We start a search for reversed transactions. We are searching for cancellations with a value exceeding HUF 10,000.



#### **Search results:**

This is the number of occasions where a purchase exceeding HUF 10,000 was cancelled in the examined period.





#### **Automatic reports**

Recurring searches can be set as default reports to be made available for further analysis and processing.

In order to comply with the data protection principles, data are deleted automatically at regular intervals upon the customer's request.
